All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the eastern side of Pinlico Road and being shown as Lot No. 92 on a Plat of Gower Estates, Section A, as recorded in the R.M.C. Office for Greenville County in Plat Book "QQ", at Pages 146 and 147, and having, according to said plat the following metes and bounds, to-wit:
