

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, on the eastern side of Old Hickory point Road, in the Town of Mauldin, being shown and designated as Lot No. 36, on a plat of FORRESTER WOODS, SECTION I, made by R. B. Bruce, RLS, dated March 14, 1973, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-N at Page 78, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Old Hickory Point Road, at the joint front corners of Lots Nos. 35 and 36, and running thence with the common line of said lots, S. 62-24 E. 160 feet to an iron pin; thence along the rear line of Lot No. 37, N. 27-36 E. 110 feet to an iron pin; thence N. 62-24 W. 160 feet to an iron pin on Old Hickory Point Road; thence along the eastern side of said Road, S. 27-36 W. 110 feet to an iron pin, the point of beginning.
