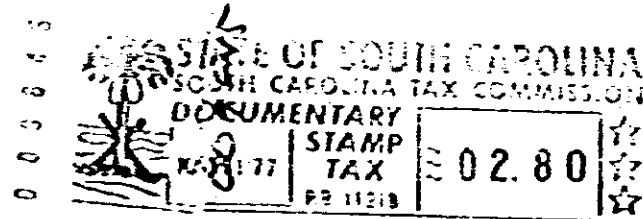
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the southern side of Lee Road, near the City of Greenville, being shown and designated as Lot No. 1 of the Property of Rachel Bruce, recorded in the R.M.C. Office for Greenville County in Plat Book T, Page 240, prepared by H. S. Brockman on May 31, 1950, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Lee Road in the corner of Tract No. 2 and running thence with Lee Road S. 72-15 W., 110 feet to an iron pin; thence running S. 9-05 E., 220 feet to an iron pin; thence running N. 80-06 E., 94 feet to an iron pin at the joint rear corner of Tracts Nos. 1 and 2; thence running with the line of Lot No. 2 N. 5-05 W., 236.2 feet to an iron pin, being the point of beginning.

This is the same property conveyed to the mortgagors by deed of Leslie & Shaw, Inc., recorded in the R.M.C. Office for Greenville County on September 30, 1959, in Deed Book 635, Page 273.
