To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Eighty Nine and 67/100 ------(\$ 289.67) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortzazor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgazor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgazor in hand well and truly paid by the Mortgazee at and before the scaling of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon or bereafter to be constructed thereon either; hinz and being in the State of South Carolina, County of Greenville, on the Northerly Side of Elbby Lane, in the Town of Mauldin, being shown and designated as Lot No. 95 on a plat of Hillsborough, Section II, made by Jones Engineering Service, dated November 1970, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book 4-F, page 51, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the northerly side of Libby Lane at the joint front corner of Lots Nos. 94 and 95; thence with the common line of said lots, N. 7-33 W., 140 feet to an iron pin; thence along the rear lines of Lots Nos. 101 and 102, S. 82-27 E., 120 feet to an iron pin at the joint rear corners of Lots Nos. 95 and 96; thence with the common line of said lots, S. 7-33 E., 140 feet to an iron pin on Libby Lane; thence with the northerly side of Libby Lane, N. 82-27 W., 120 feet to the point of beginning.
