

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Butler Township, on the west side of Richburg Road and having, according to a plat entitled Property of Burgess Goodbrad dated January 5, 1973, revised March 15, 1973, and July 30, 1973, made by Campbell and Clarkson, Surveyors, Inc. recorded in the RMC Office for Greenville, South Carolina in Plat Book 5-A, Page 123, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of Richbourg Road at a point at the joint fron corner of property of LaVerne B.
