To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of ..... Greenville...... State of South Carolina:

ALL that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the easterly side of Carr Road, contaning 1.95 acres, as shown as plat of Property of Aaron G. Sims, prepared by Carolina Surveying co., 11 September 1978, recorded in the R.M.C. Office for Greenville County, SC, in Plat Book "6 W", at Page 11, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an old spike in the center line of Carr Road and running thence with the center line of said Road, N. 26-55 E. 310 feet to a spike; thence leaving the center line of Carr Road and running with other property of Aaron Gene Sims, S. 74-08 E. 278.5 feet to an iron pin; thence S. 26-55 W. 310 feet to an iron pin in line of property of Bill Trammell; thence N. 74-08 W. 278.5 feet to an old spke, the point of BEGINNING.
