MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS,

We, EUGENE TUCKER, JR. & MARY ALICE TUCKER,

(hereinafter referred to as Mortgagor) is well and truly indebted unto LLOYD DACUS

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of THIRTEEN THOUSAND AND NO/100-----

Dollars (\$ 13,000.00) due and payable

\$172.11 per month, payments applied first to interest and balance to principal

with interest thereon from date at the rate of 10% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

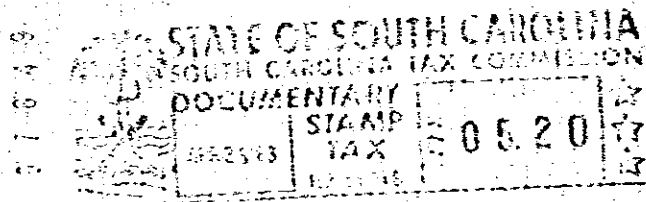
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Palmetto Avenue near the City of Greenville and shown as Lot No. 2, Block K, on plat of Riverside recorded in the RMC Office for Greenville County in Plat Book A, page 323, and also shown in Plat Book K, page 281, and having the following metes and bounds:

BEGINNING at an iron pin on the South side of Palmetto Avenue at the joint front corner of Lots 1 and 2 of Block K and running thence with line of Lot No. 1, S. 10-15 W. 125 feet to iron pin on North side of a 15-foot alley; thence along the North side of said alley S. 79-45 E. 50 feet to an iron pin; thence with line of Lot No. 3, N. 10-15 E. 125 feet to iron pin on South side of Palmetto Avenue, N. 79-45 W. 50 feet to the beginning corner.

This being the same property conveyed to the Mortgagors herein by deed of the Mortgagee herein of even date herewith and recorded in the RMC Office for Greenville County simultaneously herewith.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
