

Harper (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina corporation (hereinafter referred to as Mortgagee): WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of Thirty Thousand and No/100\_\_\_), with interest thereon, providing for monthly installments of principal and interest 1st ## LEH \_day of May My day of each month thereafter until the principal and interest are fully paid; continuing on the AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described: NOW, THEREFORE, in consideration of the aforesaid foan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located Greenville County, South Carolina: ALL that lot of land with the buildings and improvements thereon, situate on the East side of Yancey Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 15 on plat of Section One of Lake Forest Heights, recorded in the RMC for Greenville County, South Carolina, in Plat Book 'QG" at Page 153, and having according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the East side of Yancey Drive at the joint front corner of Lots Nos. 14 and 15 and runs thence along the line of Lot No. 14, N. 73-13 E. 255.8 feet to an iron pin; thence S. 19-59 E. 115.1 feet to an iron pin; thence along the line of Lot No. 16, S. 73-13 W. 262.2

feet to an iron pin on the East side of Yancey Drive; thence along Yancey Drive, N. 16-47 W. 115 feet to the beginning corner.

This is the same property conveyed to the mortgagors herein by deed of Charles W. Charlton and Gailya E. Charlton recorded in the RMC for Greenville County, South Carolina on June 6, 1974 in Deed Volume 1000 at Page 669.

This mortgage is second and junior in lien to that mortgage given in favor of Cameron Brown Company in the original amount of \$35,000.00 recorded in the RMC for Greenville County on June 6, 1974 in Mortgage Book 1312 at Page 815.



Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging of in anywise incident or appertaining. Including buy not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single Units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or wher services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, goves and water heater (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its TO HAVE AND TO HOLD the same with an privileges and approximately and Mortgagor covenants with Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above-mentioned Note and all payments required by any note(s) secured by lien(s) having priority over Mortgagee's within described lien or by any prior mortgage(s) in the amounts, in the manner and at the places set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
- 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental of municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly Reliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
