"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southwestern side of Blackburn Street and known and designated as Lot 31 as shown on a plat entitled Isaqueena Park made by Pickell & Pickell, Engineers, June 3, 1947, recorded in the RMC Office for Greenville County, South Carolina in Plat Book P, Pages 130 and 131, and having according to said plat and also according to a more recent plat prepared by Piedmont Engineering Service, dated June 13, 1958, entitled "Property of William S. Knight", the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of Blackburn Street at the joint front corner of Lots 31 and 32, and running thence along the common line of said two lots S 51-22 W 217.7 feet to an iron pin in the line of Lot 130; thence along the line of Lot 130 N 43-29 W 121.7 feet to an iron pin at the joint rear corner of Lots 30 and 31; thence along the common line of said two lots N 57-56 E 226.4 feet to an iron pin on the southwestern side of Blackburn Street; thence along the southwestern side of Blackburn Street; thence along the southwestern side of Blackburn Street S 39-10 E 96 feet to an iron pin, the point of beginning.

DERIVATION: This being the same property conveyed to Mortgagor herein by deed of Mary Dani Roberts-Robinson as recorded in the RMC Office for Greenville County South Carolina, in Deed Book //87, Page 897, on May 9, 1983.

At the option of the Mortgagee, the indebtedness secured hereby shall become due and payable if the Mortgagor shall convey the mortgaged premises or if the title thereto shall become vested in any other person or party for any other reason whatsoever.
