MORTGAGE

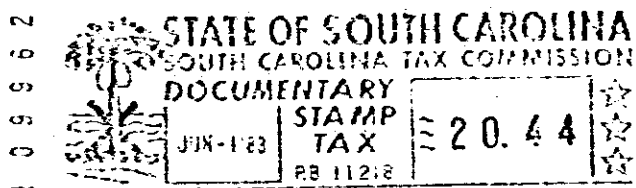
THIS MORTGAGE is made this 31st day of May, 1983, between the Mortgagor, Robert Bruce Johns, Karen Traicoff Johns and Bill J. Traicoff, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-One Thousand One Hundred and No/100 (\$51,100.00) Dollars, which indebtedness is evidenced by Borrower's note dated May 31, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 1, 2013

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel or lot of land situate, lying and being on Brushy Creek Ridge, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 5 of a subdivision known as Brushy Creek Ridge, plat of which is recorded in the REC Office for Greenville County in Plat Book 7-C at Page 25, and having such metes and bounds as shown on the recorded plat.

THIS being the same property conveyed to the mortgagors herein by deed of Dennis J. Lewis and Kathleen M. Lewis as recorded herewith in the REC Office for Greenville County, S.C..

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
