### MORTGAGE (Construction)

THIS MORTGAGE is made this 10th day of June, 1983, between the Mortgagor, FURMAN COOPER BUILDERS, INC., (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Forty-seven Thousand Two Hundred Fifty and No/100 (\$47,250.00) Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated June 10, 1983, (herein "Note"), providing for monthly installments of interest, with the principal indebtedness, if not sooner paid, due and payable on March 1, 1984.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Borrower dated June 10, 1983, (herein "Loan Agreement") as provided in paragraph 20 hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 17 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 3 of OLD MILL ESTATES, SECTION III, as shown on plat recorded in the RMC Office for Greenville County in Plat Book 8P, Page 3, and also as shown on a more recent survey prepared by Freeland & Associates, dated May 30, 1983, entitled "Property of Furman Cooper Builders, Inc.", and having according to the more recent survey, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southern side of East Mill Court at the joint corner of Lots 4 and 3 and running thence with the common line of said Lots, S 19-13-42 W 129.45 feet to an iron pin; thence with the common line of Lots 2 and 3, N 66-23-54 W 158.93 feet to and iron pin on the eastern side of Mill Estates Road; thence with said Mill Estates Road, N 22-44-12 E 80.0 feet to the intersection of Mill Estates Road and East Mill Court; thence with said intersection, N 63-43 E 37.88 feet to an iron pin on the southern side of East Mill Court; thence with said East Mill Court, S 75-03-36 E 111.35 feet to an iron pin; thence continuing with said road, S 77-59-24 E 16.0 feet to an iron pin, being the point of beginning.

This being a portion of the property conveyed to the Mortgagor herein by deed of C. S. Willingham recorded in the RMC Office for Greenville County in Deed Book 1186, Page 461 on April 15, 1983.
