THIS MORTGAGE is made this 29th day of July 1983, between the Mortgagor, Genevenia V. Robinson (herein "Borrower"), and the Mortgagee, AMERICAN SERVICE CORPORATION, a corporation organized and existing under the laws of South Carolina, whose address is Post Office Box 1268, Greenville, SC (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-three thousand six hundred fifty and no/100ths Dollars, which indebtedness is evidenced by Borrower's note dated July 29, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 1, 2013.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or unit situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Unit Number 303, Phase II of SUMMER WOODS HORIZONTAL PROPERTY REGIME as is more fully described in MASTER DEED dated September 16, 1981 and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 1155 at Pgae 564 through 634 inclusive, CORRECTION TO MASTER DEED recorded in Deed Book 1156 at Page 454, and AMENDMENT TO MASTER DEED, recorded August 12, 1982, in Deed Book 1172 at Page 62, and AMENDMENT TO MASTER DEED recorded January 6, 1983 in Deed Book 1180 at Page 410 and AMENDMENT TO MASTER DEED recorded May 27, 1983 in Deed Book 1188 at Page 981 and plat of SUMMER WOODS PHASES I AND II prepared by Kermit T. Gould, dated September 10, 1981, revised December 23, 1982 and May 12, 1983 and recorded in Plat Book 9Q at Page 30.

This conveyance is made subject to any and all reservaitons, easements, rights of way, zoning ordinances, restrictions and/or protective covenants as set out in the MASTER DEED, Exhibits and Appendices attached thereto, CORRECTION AND AMENDMENTS TO MASTER DEED, recorded plats or as may appear on the premises.
