- (7) That the Martgager shall hald and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgager shall fully perform all the terms, conditions, and coverants of the mortgage, and of the note secured hereby, that them this martgage shall be utterly null and void; otherwise to remain in full
