(C) Limit on My Unpaid Principal habited required ball Payment Amount

My anpaid principal balance can never exceed a maximum about equal to one hundred twenty-five percent (125%) of the principal amount I originally borrowed. It my paying the amount of my monthly payment calculated under Section 5 above after any Interest Change Date would cause my unpaid principal balance to exceed that maximum amount at any time, I will instead pay the Full Payment Amount as my monthly payment until the out time I may elect a Payment Increase Option under Section 5(b)

7. NOTICE OF CHANGES

The Note Helder will mail or deliver to me a notice of my changes in the full Payment Amount and my monthly payment before the effective date of any change. The notice will include information required by law to be given me.

B. CHARGES; LIENS

Uniform Covenant 4 of the Security Instrument is amended to read as follows:

Charges; Liens. Borrower shall pay all taxes assessments, and other charges, fines and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, if any, in the manner provided under paragraph 2 horeof or, it not paid in such manner, by Borrower making payment, when due, directly to the payee thereot. Borrower shall promptly discharge any tien which has priority over this Security Instrument: provided, that Borrower shall not be required to discharge any such lien which has priority over this Security instrument; provided, that Borrower shall not be required to dis harge any such lien so long as Borrover: (a) shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender; (b) shall in good faith contest such lien by, or defend against enforcement of such lien in, legal proceedings which in the opinion of Lender operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof; or (c) shall secure from the holder of such lien an agreement in a form satisfactory to Londer subordinating such lien to this Security Instrument.

Any notice provided for in this Security Instrument shall be deemed to have been given to Borrower or Lender when given in the manner designated herein.
