Thoreson is indebted to Mortgagee in the maximum principal sum of Five Thousand One Hundred Sixty-Seven and No/100----- Dollars (\$5,167.00-----), which indebtedness is evidenced by the Note of George E. Thoreson of even date herewith, said principal plus interest thereon being payable as provided for in said Note, the maturity of Sept. 1, 1988 which is 60 months after the date hereof; the terms of said Note and any agreement modifying it are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina (1976) all future advances and readances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid note, or by other promissory notes, this a, renewals and extensions thereof, and all other indebtedness of Mortgagor to Mortgagee now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby, not to exceed \$5,167.00 plus interest thereon at charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

All that piece, parcel or lot of land in Greenville County, State of South Carolina and being more particularly described as follows:

Beginning at an iron pin near a large white oak and running thence along the old line, S-74-30W 510 feet, more or less, to a county road known as Holly Drive (said road running from Fork Shoals Road to Reedy Fork Road); thence in a southeasterly direction along the said Holly Drive 330 feet to a point; thence along a newly computed line N59-30E 330 feet, more or less, to a point in the old line; thence along the old line N1-50W 210 feet to beginning corner.

This being the same property conveyed unto the Mortgagor by deed of W. E. Burnes, recorded in Deed Book 785, page 643 on November 9, 1965, and by deed of Arrah Ann Childers, formerly Arrah Ann Thoreson, executed and recorded of even date herewith.
