

funds held under the Indenture when the same shall become due; (b) duly observe and comply with all valid requirements of any governmental authority relative to the Mortgaged Property; (c) not create or suffer to be created any lien or charge upon the payments to be made by the Corporation pursuant to Section 4.01 of this Agreement other than as provided in Section 4.02 hereof to the Lender; and (d) pay, satisfy or cause to be discharged or make adequate provision to pay, satisfy or cause to be discharged, within 15 days after the same shall come into force, any lien or charge upon the Mortgaged Property, this Agreement or any payments hereunder. If the Corporation shall contest any such tax, assessment, lien or charge, such action by the Corporation shall not be considered as a breach by it of any of its covenants under this Agreement; provided, however, that in such a case an amount sufficient to pay such tax or assessment or discharge such lien or charge shall be deposited by the Corporation in escrow or the Corporation shall make other arrangements satisfactory to the Issuer and the Lender to secure such payments. Notwithstanding the foregoing, if, in the opinion of the Issuer or Lender as set forth in a written notice to the Corporation, the failure to pay such tax or assessment or remove such charge on lien before the conclusion of such contest will endanger the security for the Note, the Corporation shall immediately pay such tax or assessment or discharge such lien or charge.

SECTION 5.03. Insurance. The Corporation shall cause public liability insurance with specific reference to the Plant to be maintained and shall otherwise cause the Plant to be continuously insured against such risks as are customarily insured against by businesses of like size and type, paying as the same become due and payable all premiums with respect thereto. In lieu of separate insurance policies, such insurance may be in the form of a blanket insurance policy or policies. Insurance policies may be written with deductible amounts and exceptions and exclusions comparable to those of businesses of like size and type. All proceeds of insurance shall be made payable to the Lender as an additional loss payee. All claims under any insurance policy referred to in this Agreement may be settled by the Corporation with the consent of the Lender.
