MORTGAGE

THIS MORTGAGE is made this 20th day of September, 1983, between the Mortgagor, John Phillip Gold, Sr. and Carolyn C. Gold, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

ALL that lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Hillsborough Drive, being shown as Lot No. 53 on a plat of Merrifield Park recorded in Plat Book 000, Page 177, R.M.C. Office for Greenville County.

THIS property is subject to restrictions recorded in Deed Book 836, Page 25, and to all easements and rights-of-way of record which affect said property.

THIS is the same property conveyed to grantor herein by deed of Henry M. Spann recorded in Deed Book 870, page 287, R.M.C. Office for Greenville County.
