TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, John W. Bennett

(hereinafter referred to as Mortgagor) is well and truly indebted unto Myrielle D. Smith

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty three hundred and no/100 Dollars (\$ 4,300.00) due and payable

with interest thereon from August 1, 1983 at the rate of (legal) per centum per annum, to be paid: 20 Mills Ave. Greenville, S.C.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville to wit: My undivided one-half interest

Being known and designated as Lot 23 of Ridgewood Subdivision, according to a plat prepared by R.B. Bruce, September 27, 1971, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-R, Page 23, reference to said plat being craved for a complete and detailed description thereof. Said Lot fronts 170 feet on Ridgewood Drive; runs to a depth of 226.5 feet on its western line; runs a depth of 299.4 feet on its eastern line and is 100 feet across the rear.

This is the same property conveyed to the Mortgagor herein by deed of Realistic Builders, Inc. recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1060 at Page 46, on July 7, 1977.
