To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 17 on plat of Richmond Hills, Section Five, made by R. B. Bruce, R.L.S., dated November, 1967, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book MM at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Konnarock Circle at the joint front corner of Lots Nos. 16 and 17, and running thence with the joint line of said Lots N. 62-24 W, 150 feet to an iron pin; thence N. 27-36 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence S. 62-24 E. 150 feet to an iron pin on Konnarock Circle; thence with said Circle S. 27-36 W. 100 feet to an iron pin at point of beginning.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
