PARTIAL RELEASE OF LIEN

FOR VALUE RECEIVED, Southern Bank and Trust Company of Piedmont, South Carolina, does hereby release the below described parcel of land from the lien of a certain Mortgage heretofore given by George D. Cash, Sr., and Barbara J. Cash unto Southern Bank and Trust Company of Piedmont, South Carolina, dated May 13, 1983 of record in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Vol. 1606, at Page 869, the lands released therefrom are described as follows:

All that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, being known and designated on a plat entitled Property of Daisy B. Cash dated September 13, 1957, by J.C. Hill, L.S., as a 1.5 acre lot, and has, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Western side of U.S. Highway No. 25, joint front corner of Aliene C. Harris and property now or formerly belonging to Mrs. Rogers, and running thence along said Highway N. 7-35 E. 110.25 feet to a point; thence running S. 38-15 W. 592.6 feet to a point; thence running S. 7-35 W. 110.25 feet to a point, thence running N. 38-15 E. 592.6 feet to the point of beginning.

This is the same piece, parcel or lot of land conveyed unto George D. Cash and Barbara J. Cash, by deed of Aliene C. Harris, dated September 25, 1972, of record in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 956, at Page 417, the said George D. Cash having conveyed his interest in and to same unto Barbara J. Cash by deed dated July 15, 1983 of record in the R.M.C. Office for Greenville County, S.C., in Deed Vol. 1192, at Page 807.

PROVIDED, HOWEVER, that the security of Southern Bank and Trust Company of Piedmont, South Carolina, as described in the aforesaid security instrument shall in all respects, except as to the premises hereinabove described, be preserved and protected and that the lien of said security, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and the Note thereby secured, shall remain unchanged.
