BECINNING at an iron pin on the east side of Adams Mill Road, the joint front corner of Lots 8 and 9; thence with the joint line of said Lots S. 71-33 E. 157.4 feet to an iron pin in line of property of Donald E. Baltz; thence with the line of said property N. 18-27 W. 100 feet to an iron pin joint rear corner of Lots 7 and 8; thence with the joint line of said lots S. 71-33 W. 160 feet to an iron pin on the east side of Adams Mill Road; thence with the east side of said road S. 19-57 E. 100 feet to the point of beginning.
