THIS MORTGAGE is made this 1st day of DECEMBER, 1983, between the Mortgagor, JEFFERY W. KEY AND SUSAN H. KEY

, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").
