NOW, KNOW ALL MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgagee, its (his) heirs, successors and assigns forever, the following described real estate:

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina, on the northern side of Berkley Avenue, shown and designated as Lot No. 3 on plat of property of Dan E. Bruce and Bud Young, Jr., by Jones Engineering Services, dated April 12, 1969, and recorded in the R.M.C. Office for Greenville, Count South Carolina in Plat Book "YYY", at Page 143, being a portion of Lots 260 and 261, according to plat of property of Colonia Co. by Dalton & Neves, Engineers, dated February, 1939, and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "J", at Pages 4 & 5, and being more particularly described on plat of property of Henry Nelson Berry and Nancy G. Berry, dated May 18, 1969, prepared by jones Engineering Service, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Berkley Avenue at the joint front corner of Lots 2 & 3, said iron pin being 479 feet from the northwestern corner of the intersection of Berkley Avenue and Brockman Avenue, and running thence with the line of Lot No. 2 N. 24-13 W. 196.2 feet to an iron pin, joint rear corner of Lots 2 & 3, thence S. 65-13 W. 73.3 feet to an iron pin; thence S. 26-43 E. 195.2 feet to an iron pin on the northern side of Berkley Avenue; thence with the northern side of Berkley Avenue No. 65-47 E. 65.3 feet to an iron pin, the point of beginning.

This is the identical property conveyed to Henry Nelson Berry and Nancy G. Berry by deed of Dan F. Bruce and Bud Young, Jr. on 5-26-69 and recorded 5-26-69 in the office of the RMC for Greenville, S.C. in deed book 868 at pg. 540.

IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID SECOND LIEN ON THE ABOVE DESCRIBED TOGETHER WITH all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

PROPERTY.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgagee, its (their) successors, heirs and assigns forever.

AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee its (their) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s), his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than the unpaid balance on the said Note in such company as shall be appointed by the said mortgagee, and in default thereof, the said mortgagee, its (their) heirs, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgagee its (their) heirs, successors or assigns shall be entitled to receive from the insurance money so paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) heirs, executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, its (their) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the same so paid, with interest thereon, from the date of such payment.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or to any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgagee, its (their) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, he should the debt hereby secured be placed in the hands of an attorney at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgagee, its (their) heirs, successors or assigns, including a reasonable counsel fee (at not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagee, his (their) heirs, executors or administrators shall pay, or cause to be paid, after the said mortgagee, its (their) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgagor, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall partition in the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall remain in full force and virtue.

AND IT IS LASTLY AGREED, by and between the said parties, that the said mortgagee may hold and enjoy the said premises until payment shall be made.
