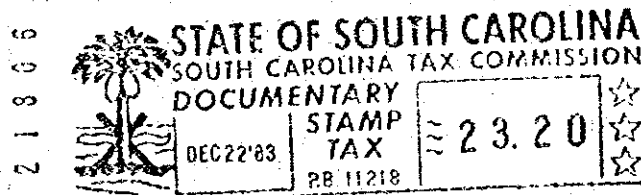

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of GREENVILLE, State of South Carolina;

ALL that certain piece, parcel or lot of land, situate, lying and being in the Town of Simpsonville, County of Greenville, State of South Carolina and being shown and designated as Lot No. 145 on a plat of Brentwood, Section IV recorded in Plat Book "5-D" at Page 43 and also on a plat recorded in Plat Book "8-E" at Page 34, RMC Office, Greenville County, South Carolina, and having according to said plats, the following metes and bounds, to-wit:

BEGINNING at a point on Brentwood Way at the joint front corner of Lots Nos. 144 and 145 and running thence S. 1-00 W. 157.6 feet to a point; thence running S. 62-08 W. 65.66 feet to a point; thence continuing S. 18-26 W. 36.9 feet to a point (creek is the property line); thence running N. 13-00 W. 229.27 feet to a point; thence running S. 89-55 E. 124.0 feet to the point of beginning.
