

**MORTGAGE**

THIS MORTGAGE is made this 18th day of January, 1984, between the Mortgagor, Brenda S. Wood, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

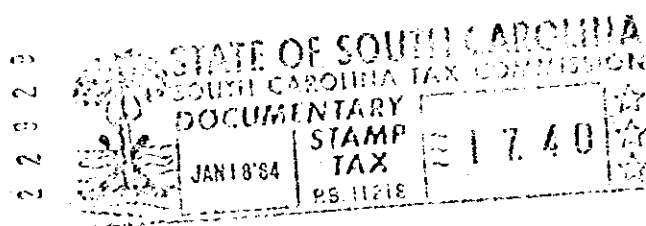

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that piece, parcel and lot of land, with all improvements thereon, situate, lying and being on the southern side of Percheron Place, in Greenville County, State of South Carolina, being shown and designated as all of LOT NO. 68 on a plat of HERITAGE LAKE SUBDIVISION, made by Heaner Engineering Co., Inc., dated March 11, 1974, revised on June 20, 1975 and on October 20, 1977, recorded in the RMC Office for Greenville County in Plat Book 6-H at page 18, and more recent survey and plat entitled "Property of Brenda S. Wood" prepared by Lindsey and Assoc., recorded in the RMC Office for Greenville County in Plat Book 10F at Page 68, reference to said plats hereby pleaded for a more complete description.

This conveyance is subject to all restrictions, easements, rights of way, and zoning ordinances of record, on the recorded plats or on the premises.
