We, Terry Wilson Wampole and Judy R. Wampole SEND GREETING:

WHEREAS, we the said Terry Wilson Wampole and Judy R. Wampole
 in and by our certain promissory note in writing of even date with these Presents, are well
 and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
 Fourteen Thousand and no/100-----(\$ 14,000.00-----) Dollars,
 with interest from the date hereof at the rate of thirteen 1/2 per cent (13.5%) per annum, unpaid interest to
 bear interest at the same rate, to be repaid in installments of

One Hundred Eighty One and 77/100-----(\$ 181.77-----) Dollars
 due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest

 Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
 Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and

 plat of property of Robert J. Edwards, made by Dalton & Neves, Engineers, June 1939,
 and being more particularly described as follows, to wit:

BEGINNING at a stake on the West side of Artillery Road, which stake is 700
 feet South of the southwest corner of Warehouse Court and Artillery Road, and running
 thence with lot No. 8, S. 59-30 W., 300 feet to a stake in line of other Edwards
 property; thence N. 30-30 W., 100 feet to a stake in line of Lot No. 6; thence with
 said lot, N. 59-30 E., 300 feet to a stake of Artillery Road; thence with said
 road, S. 30-30 E., 100 feet to the beginning.
