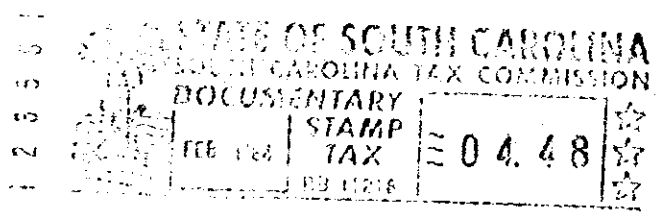

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, being known and designated as Lot 91, Section 2 on plat of Victor Monaghan Mills, which plat is recorded in Plat Book S, at pages 179-181, and having such courses and distances as will appear by reference to said plat.
