
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to of for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or tract of land, with all buildings and improvements now or hereafter constructed thereon, situate, lying and being off the eastern side of Kindlin Way Extension, in Greenville County, South Carolina, containing 0.63 acre, more or less, being shown and designated on a plat entitled "PROPERTY SURVEY FOR PEBBLEPART, LTD., 0.63 ACRE, PROPERTY KNOWN AS CLUB POINTE PHASE III", made by Arbor Engineering, dated January 27, 1984, recorded in the RMC Office for Greenville County, S. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
