"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the north-western side of Whittlin Way, being shown and designated as Lot 105 on a plat of Pebble Creek, Phase I, made by Enwright Associates, Engineers, dated September 17, 1973, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 5-D, Page 2, reference to which is hereby craved for the metes and bounds thereof.
