ADJUSTABLE RATE RIDER (Interest Rate Limits)

THIS ADJUSTABLE RATE RIDER is made this 20th day of April ,1984, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Adjustable Rate Note to First Federal Savings and Loan Association of (the "Lender") of the same date (the "Note") and covering the property described in the Security Instrument and located at:
35-D Sugar Creek Villas, Greer, SC 29651

(Property Address)

The Note contains provisions allowing for changes in the interest rate every year subject to the limits stated in the Note. If the interest rate increases, the Borrower's monthly payments will be higher. If the interest rate decreases, the Borrower's monthly payments will be lower.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of 9.875%. Section 4 of the Note provides for changes in the interest rate and the monthly payments, as follows:

"4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The Interest rate I will pay may change on the first day of May , 1985, and o that day every 12th month thereafter. Each date on which my interest rate could change is called a "Change Date."

(B) The Index

The first index figure for this note is 0.910%. It is called the "Original Index."

The Original Index plus a margin of 2.5 % (after rounding the result up to the nearest 1/8 of 1%) is called the "Adjustment Base Rate."

(C) Calculation of Changes

Before each change date, the Note Holder will calculate my new Interst rate by calculating the difference,

The result of this calculation will be the new amount of my monthly payments.

(D) Limits on Interest Rate Changes
The rate of interest I am required to pay shall never be increased or decreased on any single Change Date by more than one and three-quarters percentage points (1.75%) from the rate of interest I have been paying for the preceding twelve months.

Additionally, my interest rate shall never be greater than six percent (6%) above or below the "initial Interest Rate."

(E) Effective Date of Changes

My new Interest rate will become effective on each Change Date, I will pay the amount of my new monthly
payment beginning on the first monthly payment date after the Change Date until the amount of my monthly payment
changes again.

(F) Notice of Changes

The Note Holder will mail or deliver to me a notice of any changes in the amount of my monthly payment before the effective date of any change. The notice will include information required by law to be given me and before the effective date of any change.
