If Note Holder exercises such option to accelerate, Note Holder shall mail Borrower notice. then in accordance with paragraph 14 hereof. Such notice shall provide a period of not less than 30 the date the notice is mailed within which Borrower may pay the sums declared due. If Borrower factures prior to the expiration of such period, Note Holder may, without further notice or demand on trower, invoke any remedies permitted by paragraph 18 hereof.
