
FIRST UNION MORTGAGE CORPORATION, CONS-14, CHARLOTTE, N. C. 28288

THIS MORTGAGE made this 26th day of April 19 84
among <u>LEONARD G. HILL and DONNAL. HILL</u> (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina corporation (hereinafter referred to as Mortgagee):
WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of Twenty-Five Thousand and No/100
Dollars (\$ 25,000.00), with interest thereon, providing for monthly installments of principal and interest
beginning on the lst day of day of, 19
continuing on theday of each month thereafter until the principal and interest are fully paid;
AND WHEREAS, to induce the making of said toan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:
NOW, THEREFORE, in consideration of the aforesaid loand and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:
ALL that certain piece, parcel or lot of land, situate, lying and being in Oneal Township, County of Greenville, State of South Carolina, located about three miles Northwest of the City of Greer, and being known and designated as Lot No. 20 as shown on plat of property made for Fred Bishop by H. S. Brockman, Surveyor, dated November 5, 1957, recorded in the RMC Office for Greenville County, S. C. and having, according to said plat, the following metes and bounds:
BEGINNING at an iron pin at the joint front corner of Lots Nos. 19 and 20, and running thence, S. 63-25 W. 318.4 feet to an iron pin; thence N. 4-12 E. 127.3 feet to an iron pin; thence N. 63-25 E. 237.5 feet to an iron pin thence S. 34-51 E. 110 feet to the beginning corner.
This is the same property conveyed to the Mortgagors herein by deed of McElrath & Tucker, Inc., dated April 20, 1978, and recorded in the RMC Office for Greenville County, S. C. in Deed Book 1078, at Page 126, on April 28, 1978.



Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvments, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heater (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its o successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above-mentioned - Note and all payments required by any note(s) secured by lien(s) having priority over Mortgagee's within described lien or by any prior mortgage(s) in the amounts, in the manner and at the places set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
 - 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
