NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

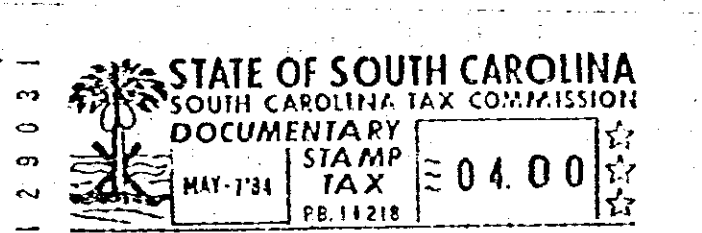
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL those two certain piece, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District B-AA, being known and designated as Lots Nos. 19 and 20, of Block E of a subdivision known as "Sunny Slope", as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book F at page 86, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Agnew Avenue at the corner of Lot No. 18, of Block E, and running thence along the line of that lot, N. 23-49 E. 150 feet to an iron pin at the rear corner of said lot; thence S. 66-11 E. 100 feet to an iron pin at the rear corner of Lot No. 21, of Block E; thence along the line of that lot, S. 23-49 W. 150 feet to the corner of said lot on the north side of Agnew Avenue; thence along the north side of Agnew Avenue N. 66-11 W. 100 feet to the beginning corner.
