

MORTGAGE

THIS MORTGAGE is made this _____ day of May, 19 84, between the Mortgagor, Jesse L. French and Judith A. French, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

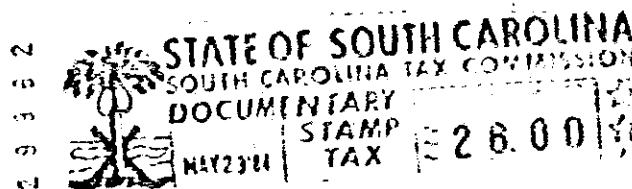
WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty Five Thousand and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated May 17, 1984, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 1, 2014;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

in the City of Simpsonville, on Woodhill Lane, and being known and designated as Lot 82 of a subdivision known as Holly Tree Plantation, Phase III, as shown on plat thereof prepared by Piedmont Engineers, Architects & Planners Surveyors, dated September 1, 1978, recorded in the RMC Office for Greenville, South Carolina in plat book 6-G at page 74, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Woodhill Lane, the joint front corner of Lots 82 and 83, and running thence S. 73-55 W., 168.47 feet, more or less, to an iron pin at the joint rear corner of Lots 82 and 83; thence turning and running along the joint rear line of Lots 82 and 116 N. 13-04 W., 110 feet, more or less, to the joint rear corner of Lots 81 and 84; thence turning and running along the joint line of Lots 81 and 82 N. 75-19 E., 204.25 feet, more or less, to an iron pin at the joint front corner of Lots 81 and 82 on the western edge of Woodhill Lane; thence turning and running along the western edge of Woodhill Lane S. 16-16 W., 60 feet, more or less, to an iron pin; thence continuing along the western edge of Woodhill Lane, S. 6-20 E., 55 feet, more or less, to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Foothills Delta P recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1173 at Page 24, August 30, 1982.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
