"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land, lying, situate and being in Greenville County, being shown and designated as Lot 81A on plat entitled "Property of Palmetto Builders of Greenville, Inc." and having according to said plat, the following metes and bounds, to-wit:

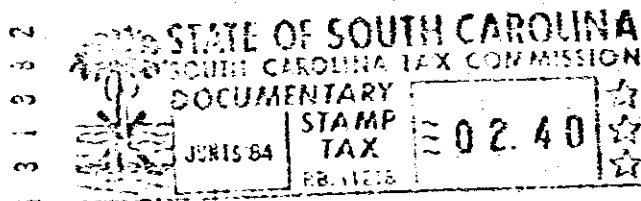
