NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

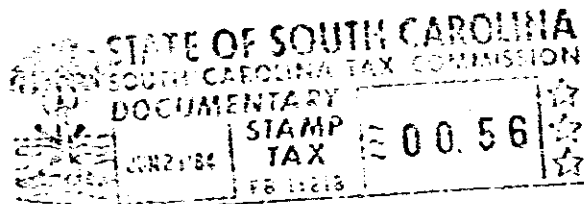
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being at the northeast corner of Mooremont Avenue and Fairfield Road and being known and designated as Lot No. 16 on a plat entitled "Property of Nathaniel E. Jones and Delores S. Jones", dated May 12, 1977 and prepared by R. B. Bruce, and having according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin located along the eastern edge of Mooremont Avenue and running N. 84-28 E. 135.5 feet to an iron pin; thence turning and running S. 5-32 E. 86.4 feet to an iron pin located along the right-of-way of Fairfield Road; thence turning and following the right-of-way S. 83-08 W. 110.04 feet to an iron pin; thence turning and running N. 49-58 W. 35 feet to an iron pin; thence turning and running N. 5-32 W. 64.4 feet to the point of beginning.
