MORTGAGE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand One Hundred and no/100-----

with interest thereon from date at the rate of 12.5 per centum per annum, said principal and interest to be repaid:

Due and payable in monthly installments of Sixty Nine and 75/100 (\$69.75) Dollars per month beginning October 7, 1984, and continuing on the same day of each month thereafter, with the entire unpaid balance due on or before five years from September 7, 1984.

This is a second mortgage.

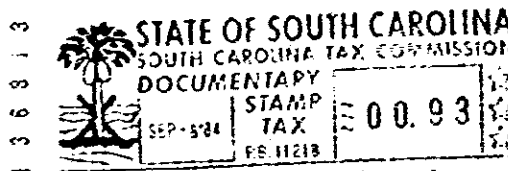

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 9 on plat of Property of Mrs. B. E. Burns, recorded in Plat Book C at page 30 and having such courses and distances as will appear by reference to said plat.

Being the same property conveyed by Kathy Marie Looper Noon by deed recorded herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
