THIS MORTGAGE is made this 27th day of September, 1984, between the Mortgagor, Kenneth C. Cosgrove

, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

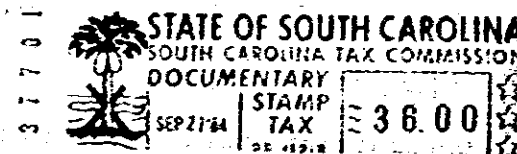
WHEREAS, Borrower is indebted to Lender in the principal sum of One Hundred Twenty Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note/agreement dated September 27, 1984 (herein "Note"), said principal sum being payable as set forth in said note with interest at the rate set forth therein, with the balance of the indebtedness, if not sooner paid, due and payable on September 27, 1987, subject to future advances or renewals.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being shown on survey entitled "Property of Kenneth C. Cosgrove" as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 10-Y at Page 33 and havng according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of East Lee Road at the intersection of East Lee Road and Edwards Road and running thence S. 27-32 E. 19.0 feet to an iron pin; thence S. 34-04 W. 137.45 feet to an iron pin; thence S. 37-37 W. 189.88 feet to an iron pin; thence S. 45-04 W. 36.20 feet to an iron pin; thence N. 44-23 W. 93.55 feet to an iron pin; thence N. 04-53 W. 211.67 feet to an iron pin; thence N. 84-22 E. 294.64 feet to an iron pin, the point of beginning.
