Payment percentage shall be computed on a quarterly basis of five percent (5%) rounded out to the nearest quarter.

- The City of Greenville shall have a lien on the real property described herein for any portion of the grant amount due.
- Upon payment of the declining balance, if any, owed to the City of Greenville or upon the expiration of five years from today, whichever occurs first, this Real Property Agreement shall be void and of no effect. Until then, it shall apply to and bind me, my heirs and devisees.
