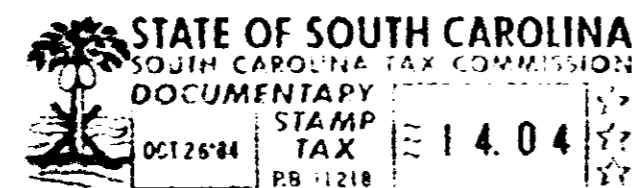
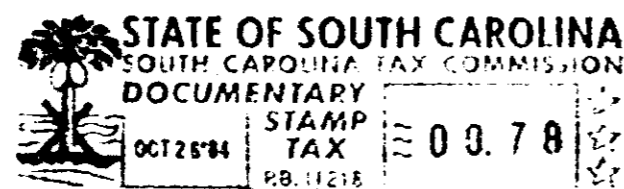

## MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on OCTOBER 26  
 1984. The mortgagor is ROBIN R. SUMMERS  
 ("Borrower"). This Security Instrument is given to ALLIANCE  
MORTGAGE COMPANY, which is organized and existing  
 under the laws of the State of Florida, and whose address is P. O. Box 4130,  
Jacksonville, Florida, 32231 ("Lender").  
 Borrower owes Lender the principal sum of FOETY-NINE THOUSAND, FOUR HUNDRED AND  
NO/100 Dollars (U.S. \$49,400.00). This debt is evidenced by Borrower's note  
 dated the same date as this Security Instrument ("Note"), which provides for monthly payments, with the full debt, if not  
 paid earlier, due and payable on NOVEMBER 1, 2014. This Security Instrument  
 secures to Lender: (a) the repayment of the debt evidenced by the Note, with interest, and all renewals, extensions and  
 modifications; (b) the payment of all other sums, with interest, advanced under paragraph 7 to protect the security of this  
 Security Instrument; and (c) the performance of Borrower's covenants and agreements under this Security Instrument and  
 the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and  
 assigns the following described property located in GREENVILLE County, South Carolina:

 situate on or near the Southerly side of Pelham Road, in the City of  
 Greenville, County of Greenville, State of South Carolina, as more

 replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this  
 Security Instrument as the "Property."

 mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record.  
 Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any
