MORTGAGE

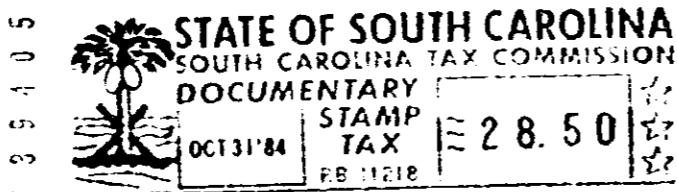
Ninety-five Thousand And No/100-----Dollars (U.S. \$ 95,000.00).
