THIS MORTGAGE is made this 9th day of November, 19 84
 between the Mortgagor Stan T. Tew
 (herein "Borrower"), and the Mortgagee, Wachovia Mortgage Company,
 a corporation organized and existing under the laws of North Carolina,
 whose address is Post Office Box 3174 Winston-Salem, North Carolina 27102
 (herein "Lender").

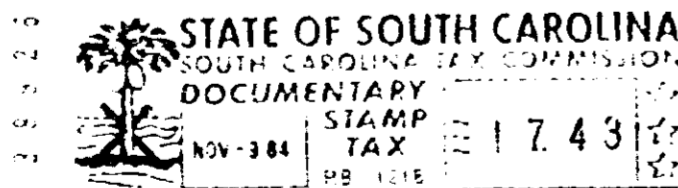
WHEREAS, Borrower is indebted to Lender in the principal sum of \$58,050.00,
 which indebtedness is evidenced by Borrower's Note dated November 9, 1984 (herein "Note"),
 providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner
 paid, due and payable on December 1, 20 14.

 hereof (herein "Future Advances") Borrower does hereby mortgage, grant, and convey to Lender and Lender's
 successors and assigns the following described property located in the County of Greenville,
 State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying
 and being in the State of South Carolina, County of Greenville
 known and designated as Unit 77 on plat of JAMESTOWNE II,
 recorded in the RMC Office for Greenville County in Plat Book
 9W, at Page 33 and also as shown on a more recent survey by
 Freeland and Associates, dated November 6, 1984, entitled
 "Property of Stan T. Tew", recorded in the RMC Office for
 Greenville County in Plat Book 11-C, Page 7, and having,
 according to the more recent survey the following metes and
 bounds, to-wit:
