NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

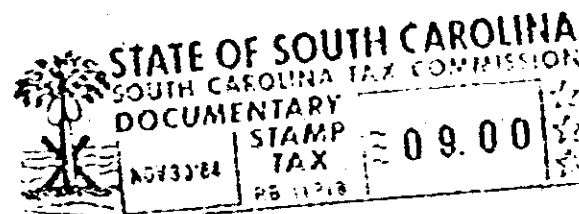
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that certain piece, parcel or lot of land, lying, situate and being in the County of Greenville, State of South Carolina containing approximately 13.72 acres as shown on survey entitled "Property of W. King Bramlette Estate" and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in the middle of SC Highway 112 at the northern most corner of the property and running thence N. 46-02 E. 517.36 feet to an iron pin; thence N. 15-13 W. 645.58 feet to an iron pin; thence N. 14-53 W. 394.76 feet to an iron pin; thence N. 31-18 E. 265.0 feet to an iron pin; thence N. 48-34 W. 99.12 feet to an iron pin; thence S. 26-14 W. 1308.82 feet to an iron pin in the middle of SC Highway 112; thence with the middle of the road S. 42-32 E. 363.07 feet to a nail and cap; thence continuing with the middle of the road S. 38-09 E. 272.30 feet to the point of BEGINNING.
