WRAP-AROUND PURCHASE MORES MORTGAGE OF REAL ESTATE AND SECURITY AGREEMENT

THIS MORTGAGE is made this day of December, 1984, between J. M. MORTGAGE, INC., a Tennessee corporation, hereinafter sometimes referred to as "Mortgagor" and "Borrower," and PELHAM ASSOCIATES LIMITED PARTNERSHIP, a South Carolina limited partnership, hereinafter sometimes referred to as "Mortgagee" and "Lender."

RECITALS

Borrower is indebted to Lender for the balance of purchase money in the principal sum of One Million Nine Hundred Seventy-Five Thousand and No/100 (\$1,975,000.00) Dollars, which indebtedness is evidenced by Borrower's All-Inclusive Promissory Note of even date herewith, (hereinafter the "Wrap Note"), providing for payment of principal and interest as stated in the Wrap Note, which if not sooner paid, shall be due and payable in full eight (8) years from the date hereof; and

The indebtedness evidenced by the Wrap Note includes certain existing indebtednesses, (hereinafter the "Prior Notes"), which Prior Notes are listed in Schedule "A", which is attached hereto and incorporated herein by reference; and

This Mortgage "wraps around" and includes existing mortgages, (hereinafter the "Prior Encumbrances"), on the hereinafter defined "Property," which Prior Encumbrances are also listed in said Schedule "A" hereto; and

Mortgagor has purchased the hereinafter defined "Property" from Mortgagee on this date subject to, but not assuming, the Prior Notes; and

To satisfy the payment requirements of the Prior Notes and the Prior Encumbrances, Mortgagor and Mortgagee have this date entered into a Collection Agreement, (hereinafter the "Collection Agreement") with CITIZENS AND SCATTERS NATIONAL BANK OF SINK CARRINAT (Nachville City Bank & Trust Co., (hereinafter the "Collection Agent") the terms and conditions of which Collection Agreement are incorporated herein by reference.
