THIS MORTGAGE is made this 11 th day of December, 1984, between the Mortgagor, CURTIS E. and AMANDA N. CAMPBELL, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of twelve thousand three hundred twenty six dollars & 16 cents (\$12,326.16) Dollars, which indebtedness is evidenced by Borrower's note dated 12-11-84, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on 12-31-89

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 4, FERNCREEK SUBDIVISION, on plat thereof prepared by Dalton & Neves Co., Engineers, dated November, 1973, and recorded in the RMC Office for Greenville County, S. C., in Plat Book 5-D, at page 28, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the southeastern side of of Ferncrest Drive at the joint front corner of Lots Nos. 4 and 5, and running thence with the line of said lots, S. 19-49 E., 394.1 feet to a point in the center of a creek; thence with the creek being the rear line, the traverse of which is as follows: N. 62-53 W., 93 feet; thence S. 46-05 W., 85 feet to an iron pin, joint rear corner of Lots Nos. 4 and 3; thence running with the line of said lots, N. 39-43 W., 297.3 feet to an iron pin in the southeastern side of Ferncrest Drive; thence with the southeastern side of said Drive, the following courses and distances: N. 39-20 E., 40 feet to an iron pin; thence N. 44-10 E., 72.9 feet to an iron pin; thence N. 53-50 E., 72.9 feet to an iron pin; thence N. 63-30 E., 72.9 feet to an iron pin, point and place of beginning.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
