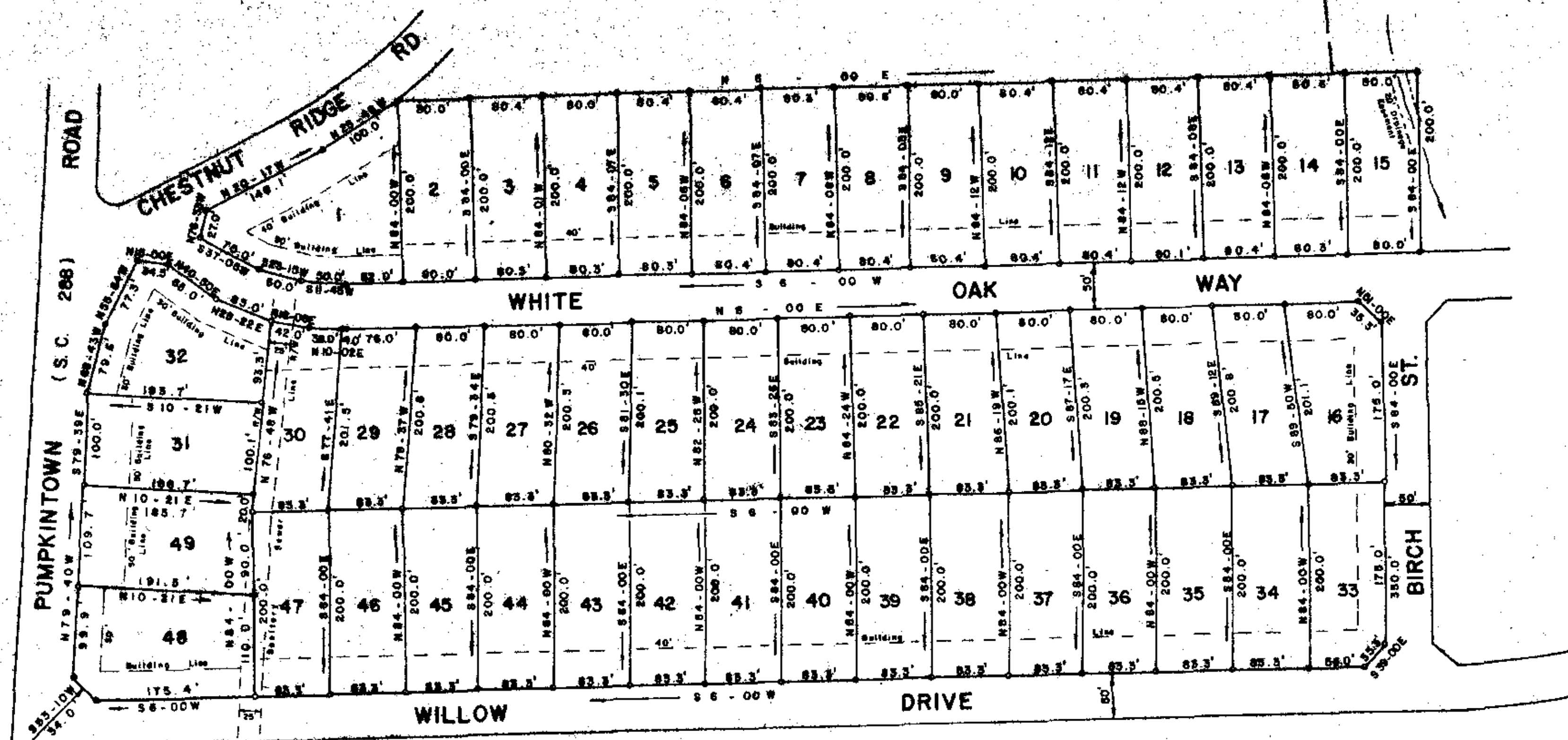
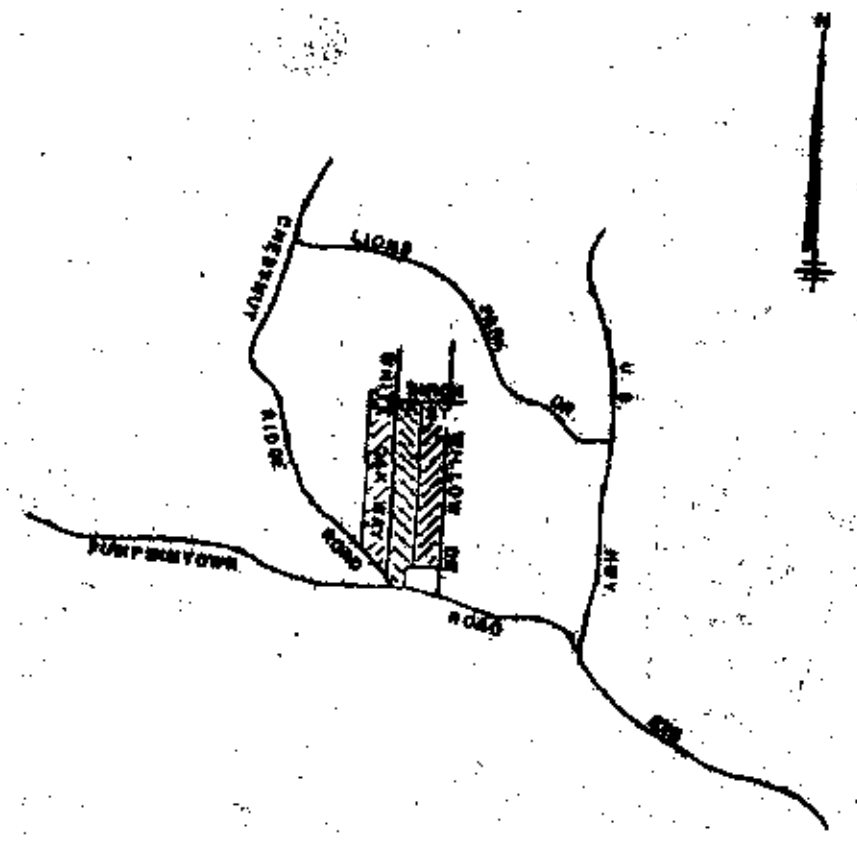

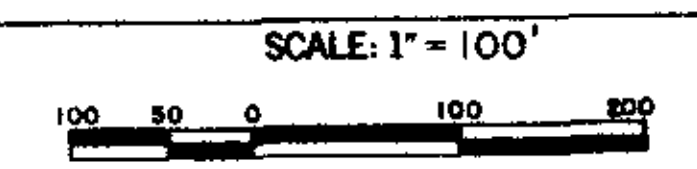


LOCATION MAP
