TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE SECURES FUTURE ADVANCES - MAXIMUM OUTSTANDING \$100,000.

WHEREAS, Robert L. Wilson

MCC Financial Services, Inc.

(hereinafter referred to as Mortgagor) is well and truly indebted unto its successors and assigns forever (hereinafter referred to as Mortgagee) as evidenced by the

Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four Thousand Three Hundred Twenty Dollars & No/100 -----Dollars (\$ 4320.00) due and payable in monthly installments of \$ 120.00 , the first installment becoming due and payable on the 20th day of July , 19 76 and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand.

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville , to wit:

Being shown as Lot No. 20 on a plat of Golden Strip Subdivision, recorded in Plat Book TT at page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Wenck Circle at the joint corner of Lots 20 and 21 and running thence with the northern side of Wenck Circle, N. 66-40 W. 75 feet to the joint front corner of Lots 19 and 20; thence along the line of Lot 19, N. 23-20 E. 308.4 feet to an iron pin; thence, N. 80-41 E. 72 feet to an iron pin; thence, N. 41-56 E. 45.9 feet to a point; thence along the line of Lot 21, 23-20 W. 390.5 feet to the point of Beginning.
