All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northern side of McCarter Avenue, in Butler Township, as shown on plat of Section # 2 of Lake Forest Heights, recorded in Plat Book KR at Page 105, and being more particularly described as follows:

BEGINNING at an iron pin on the northern side of McCarter Avenue, at the joint front corner of lots # 23 and 22, and running thence with the line of lot # 22, N. 20-39 W. 185 feet; thence S. 74-39 W. 155.4 feet, more or less, to pin in center of a branch; thence with the center of the branch as the line, in a Southeasterly direction to an iron pin, where said branch crosses the northern edge of McCarter Avenue; thence with the northern side of McCarter Avenue, N. 77-07 E. 120 feet, more or less, to iron pin, the joint front corner of lots # 22 and 23, the point of beginning.
