WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Five Thousand Six Hundred and No/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot 66 on the northwestern side of Dexter Drive on a Plat of Drexel Terrace, prepared by Piedmont Engineering Service, dated April 1, 1961, said plat being recorded in Plat Book QQ at Page 177 and being more fully described as follows:
