WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ---Thirty-Two Thousand, Seven Hundred and No/100-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the corner of Seabury Lane and Future Street, shown as Lot No. 102 on plat of Merrifield Park, Section I, recorded in Plat Book 000 at Page 177 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:
